#### **GENERAL BUSINESS ACTION ITEMS:**

#### #1 Employee Education Policy

The Board discussed Eduardo's tuition cost and was presented with an employee education policy drafted by Executive Director Elizabeth Harper. The education policy allows each employee an allowance of up to \$2,000 a year to spend on continuing education that is relevant to their job. Tuition may be reimbursed to the employee or directly paid through the RCD. Unused funds will not be paid out nor rollover to the next year. If the tuition or cost of the educational program is over \$2,000, the CCRCD board will review and approve the program on a case-by-case basis. Approval of the educational program for the employee will be formalized in an agreement. The ad hoc committee for the education policy, Director Gobel and Director Nall met prior to the board meeting and developed this RCDs policy after reviewing other RCD's policies. The direct agreement with employee Eduardo Blancas was developed and approved in the board meeting along with the remaining business action items.

### #2: Vehicle Policy-Fee Structure

The Board was presented with a vehicle policy fee structure. The rates were taken from the CAL TRANS Labor Surcharge and Equipment Rental Rate Book and the CAL TRANS Equipment Rental Rate Approximation Tool. A mileage chart will also be used to log the miles.

Struckmeyer moved to approve Blancas' tuition along with the Employee Education Policy and Vehicle Policy-Fee Structure. The motion was seconded by Gobel. The motion carried with 6 Ayes, 0 Noes, 1 Absent, 0 Abstain, 0 Vacant.

#### **INFORMATIONAL/DISCUSSION ITEMS**

1. Director requirements: Ethics and Anti-Harassment Training
